Field evaluation testing has been completed for the above referenced system. The three year evaluation performed at the College Drive overpass in Baton Rouge, La indicates this paint system performed comparable to the MS-285-003 paint system in the areas of blistering, rusting, fading, chalking and adhesion. The adhesion results are listed below.
